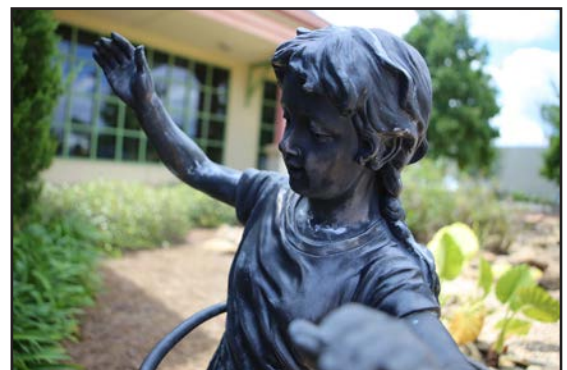

## Spotlight on Prevention & Healing



Gulf Coast Kid's House has been working hard on our child abuse prevention program. In addition to providing child abuse prevention education for Escambia County's K-12 students, we have been educating adults through our Know Child Abuse campaign. GCKH is recruiting local businesses to become a Business In The Know. A Business In the Know commits 100 percent of their staff to completing the Know Child Abuse training and makes the training a part of their new employee orientation. Gulf Coast Kid's House identified a gap when our therapy partner, Lutheran Services Florida (LSF), had a waitlist for therapy. To fill the need for immediate crisis intervention and stabilization, we created a Life Skills Counseling position. In January, we welcomed our first Life Skills Counselor. The Life Skills Counselor offers counseling services for families referred to GCKH for abuse allegations. The goal with this position is to keep a degree of flexibility so that they can work with families that are not appropriate referrals for LSF.

### Consider:

- Over **93%** of Gulf Coast Kid's House expenses are program related
- Last year, volunteers provided **1,953 hours of service**, saving GCKH over **\$58,492**
- Last year, GCKH participated in **200+** outreach activities – expanding the community's understanding of our mission immeasurably
- Last year, local businesses and individuals provided in-kind goods and services, saving GCKH nearly **\$30,000**
- Nearly **68%** of the 2021-2022 contributions that fund Gulf Coast Kid's House Legacy Programs (excluding CPT) came from the local community

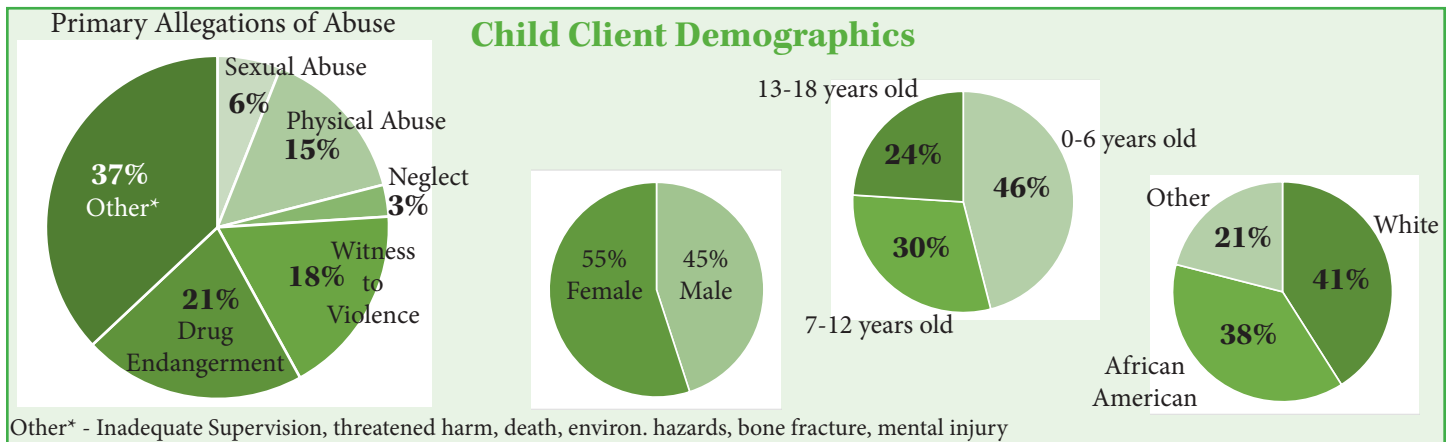

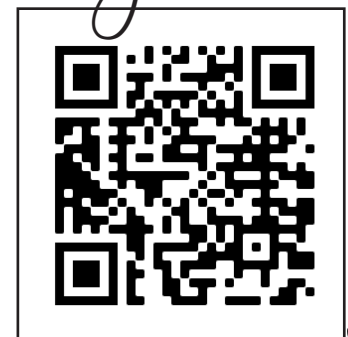
